

# **Live Oak International Rules & Regulations**

## **GENERAL RULES & REGULATIONS**

The Live Oak Tournament will be conducted according to the current rules of the FEI, the USEF and the Organizing Committee of Live Oak.

In entering Tournaments at Live Oak you and your team (owners, trainers, grooms, family members, agents, etc.) have agreed to honor the General Information as specified in this Prize List and on the entry form. Your agreement and acceptance of all rules, regulations and Live Oak decisions, are indicated by competing at our Tournament.

BRING THIS PRIZE LIST AND A COPY OF YOUR ENTRY FORM WITH YOU TO THE TOURNAMENT FOR EASY, ACCURATE REFERENCE.

## VETERINARY/HEALTH REQUIREMENTS

A negative Coggins test is required for every horse entering the tournament grounds (valid within 1 year of the start of the tournament). A Health Certificate, within 30 days, is required for horses entering State of Florida. FEI entries are required to have the appropriate vaccinations, and passports as per their discipline.

Each Horse showing and non showing must have the attached Statement of Health signed by a licensed veterinarian.

## ARRIVALS

THE STABLES OPEN AT 9:00 AM ON TUESDAY, FEBRUARY 23rd, 2016. There is a \$500 fine for horses arriving prior to this time unless you have written permission from the organizer.

## **STABLE CREDENTIALS**

Credentials for entry to the stable area will be issued as follows: Athlete-1; Partner-1; Trainer-1; Owner up to 2; Groom for jumping-1; Four in Hand entries - 4 Grooms, Pairs-3, and Singles-1. Additional credentials may be purchased for \$100 from Tournament Office.

## CHECK-IN

Please check in with the Secretary's Office once your horse has arrived - the office opens at 9:00 AM Tuesday, February 23rd, 2016.

## PARKING

There will be designated parking areas on the grounds for competitors' vehicles and trailers. Please park in designated areas only - vehicles and trailers will be towed if parked in restricted areas.

#### DIRECTIONS

Exit I-75 & SR 40 (Exit 352). Go west on Hwy 40 approximately 6 miles to SW 110th Ave. Turn left, go 1.4 miles to the top of the hill, competition is on the left. Stabling is approximately 1h mile further on the left.

#### CAMPING

There is camping space available for competitors only. There is a \$100 charge camping grounds fee, no hookups. Hookups with water and electric are \$350. Make reservations on entry form.

#### FEED AND BEDDING

Initial bedding is not provided. Shavings can be ordered for \$6 a bag. Hay can purchased through the horse show office. No Feed is available for purchase - please plan accordingly.

## PETS, LOST & FOUND

PETS: Please keep all pets on a leash while at Live Oak. Unleashed pets which become a nuisance (running loose, are aggressive to people/ horses) on the grounds will be taken by our security personnel to a safe area on the grounds. Release may be obtained after payment of a \$100 fine - dogs that are aggressive or vicious will be banned from the grounds.

LOST & FOUND: The Lost & Found Bin is located in the Secretary's Office. Items not claimed within two weeks of the end of the Tournament will be donated to charity. **PLEASE KEEP A CLOSE WATCH ON YOUR BELONGINGS!** 

#### **SMOKING**

There is a strict **NO SMOKING** policy in all Live Oak buildings and stables, as well as within **10** feet of any entrance thereof. Competitors are responsible for the actions of all their staff, owners, trainers, etc. Any person caught smoking in a barn, other building, or outside an entrance will be assessed a fine of \$250, which will be applied to the horse's account. Further offenses may result in being asked to leave the Tournament grounds and a forfeiture of Tournament fees paid.

#### TIME SCHEDULES

**THE SCHEDULES IN THIS PRIZE LIST ARE TENTATIVE**. Please check with the Secretary's Office or Liveoakinternational.com for the most up-to-date schedule.

#### **PRACTICE AREAS & SCHOOLING HOURS**

Schooling is only permitted in designated areas and at designated times. Please obtain a schedule from the Secretary's Office.

#### **HORSE BRIDLE NUMBERS**

1. Horse bridle numbers must be worn by horses at all times (including in the exercise and competition areas) with the exception of the horse's stall - FEI Article 114.2. Use of the wrong bridle number or not having a bridle number may result in disqualification.

2. Bridle numbers are provided by Live Oak at the time of Check-In. Competitors are welcome to use their own numbers provided they are easily legible (please see the Competitions Manager if you have concerns about your bridle numbers).

## TOURNAMENT AREA CONDUCT

- 1. No persons other than the officials, stewards, staff on duty, and the judges of the competition may enter the competitive ring without the permission of the Competitions Manager or the Organizing Committee.
- 2. Competitors require formal attire as per FEI and USEF rules. Coaches, trainers and grooms who enter the Competitive Ring must be NEAT AND SUITABLY ATTIRED in the opinion of the Hitching Ring officials. Please ask the Competitions Manager for dress code advice. This applies to all course inspections.
- 3. Saluting Protocol: Saluting is very important in giving the sponsors full value. You should stay alert to the Gate Person's instructions on where to salute once in the ring.
- 4. The Organizing Committee may determine to preload or not preload at any time during the competition.
- 5. Competitors are only allowed in the Competitive Ring when competing or when the course is clearly marked "**OPEN**".

## PROTESTS

Competitors have accepted favorable and unfavorable rulings in the spirit of good sportsmanship. Feel free to bring your unofficial concerns to our Competitions Manager for consideration. If you insist on making an official protest, it shall be made in writing and delivered to the Tournament Organizer accompanied by a deposit of \$163.98 cash which will be forfeited if the protest is not sustained.

#### **ORGANIZING COMMITTEE DECISIONS**

- 1. IT IS IMPORTANT TO UNDERSTAND THAT INTERPRETATIONS OF EXISTING RULES AND REGULATIONS AND THE INVOKING OF ADDITIONAL RULES AND REGULATIONS TO COVER UNFORESEEN CIRCUMSTANCES ARE THE SOLE RESPONSIBILITY AND AUTHORITY OF THE ORGANIZING COMMITTEE. ALL OWNERS, TRAINERS, COMPETITORS AND GROOMS AGREE TO THE ACCEPTANCE OF THESE INTERPRETATIONS AND ADDITIONAL RULINGS BY VIRTUE OF YOUR SIGNED ENTRY.
- 2. It is the objective of the Organizing Committee to run Live Oak Tournaments on the highest possible level of sportsmanship. Judges, Course Designers, and Officials have been selected based on their knowledge and experience and their decisions in the competitions are their own responsibility. The Organizing Committee accepts no responsibility for their decisions.
- 3. The Organizing Committee is not bound by opinions of its staff, such as Veterinary Doctors, Secretary's Office and Field Staff, in the interpretation of these rules.

#### **USEF MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the

Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 nonmember registration fee. Participants in the following classes are exempted from the Requirements of this rule: 1) lead-line; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THERE WITH.

## **EXCUSING OR DISQUALIFYING**

- 1. Any act of discourtesy or disobedience to the Judges, Officials or Staff shall, at the determination of the Organizing Committee, result in disqualification. Such unacceptable behavior will result in forfeiture of Tournament fees paid and prize money, and acceptance in future Tournaments will be determined by the Organizing Committee.
- 2. The Organizing Committee reserves the right to remove any groom, trainer, rider, driver, parent, manager or owner or all of a related group from the Tournament without being liable for compensation.
- 3. Inhumane treatment of a horse on the grounds is forbidden and if a violation occurs the Organizing Committee has the right to disqualify the competitor from the Tournament. Such unacceptable treatment will result in forfeiture of Tournament fees paid and prize money, and acceptance in future Tournaments will be determined by the Organizing Committee. Refer to Welfare of the Horse, Code of Conduct, Ethic Committee, FEI Nov. 1990.
- 4. In jumping competitions, judges have the discretion to eliminate a competitor after a sufficient number of penalties have been incurred which prevent the athlete from qualifying for the final placing.
- 5. In the case of a disqualification of a horse or horses, the winner of the next succeeding prize shall take the prize that had been awarded to the disqualified horse(s) and the other prizes will be adjusted accordingly.

#### **CODE OF CONDUCT**

Live Oak is committed to the highest of standards of behavior and the sports of driving and show jumping and expects the same standards, conduct and behavior from its athletes and their associates.

Disrespect of these standards towards the Live Oak staff, officials, volunteers, paramedics, or athletes will not be tolerated and may result in the disqualification of horse and rider; all prize money won and monies paid will be forfeited. There will be no appeals on these types of Organizing Committee/Ground Jury decisions.

In the event medical care is required by an individual on Live Oak property, the medical services on site have been contracted and authorized by Live Oak to provide immediate care and have the authority to make decisions in this capacity, including but not limited to: level of care and transportation method to the appropriate treatment facility, should it be deemed necessary.

**NOTE CAREFULLY**: Extremes of dress and social behavior on the part of athletes, trainers, owners or associates are not welcome at Live Oak. At its sole discretion, the Organizing Committee will insist on such individuals leaving the Tournament grounds. Your enthusiasm for high personal standards and adoption of the highest of standards can be your real and meaningful way of supporting and saying thank you to Live Oak.

Willful damage of property is strictly prohibited and grounds for expulsion from the facility.

All the people of Live Oak; our professional staff, officials, technicians, our sponsors, the media and our fans are dedicated to you and will make every effort to ensure safe, quality competitions and facilities.

Live Oak reserves the right to suspend or permanently remove any individual from the grounds for a single egregious act or for escalating behaviors that are contradictory to the Live Oak Code of Conduct. **BY ENTERING THE TOURNAMENT YOU ARE ACCEPTING ALL THE RULES AND REGULATIONS INCLUDING THE CODE OF CONDUCT.** 

## LIABILITY

All owners and competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

Neither the Live Oak Tournaments nor the Organizing Committee or owners of Live Oak, nor any of its staff or agents shall be in any way liable for any accident, injury, damage, loss or for any other matter that may happen, from any cause or circumstances whatsoever, to exhibitors, competitors or members of their family or their agents or to anyone on the Tournament grounds or to any animal or article exhibited or to any property brought on the Tournament grounds or for any other loss, claim, matter, circumstance or event whatsoever in connection with or arising out of or attributable to the Tournament or any journey to or from the Tournament.

It is to be understood and agreed that under no circumstances shall Live Oak, its owners, agents, employees, or family be liable for any loss, damages, claims or costs occasioned or suffered by any exhibitor, competitor, members of their family, or their agents, directly or indirectly, howsoever arising, including without limitation, losses, damages, claims or costs as a result of Live Oak, its owners, agents or employees negligence, and you agree to indemnify and save harmless Live Oak, its owners, agents and employees from and against any and all liability arising out of any such loss, damages, claims or costs.

## **DRIVER'S LICENSE STATEMENT**

Violations of this rule will be cause for sanctions against the parent(s), guardian(s), and/or trainer(s) from the competition grounds for the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. USEF GR901.29
