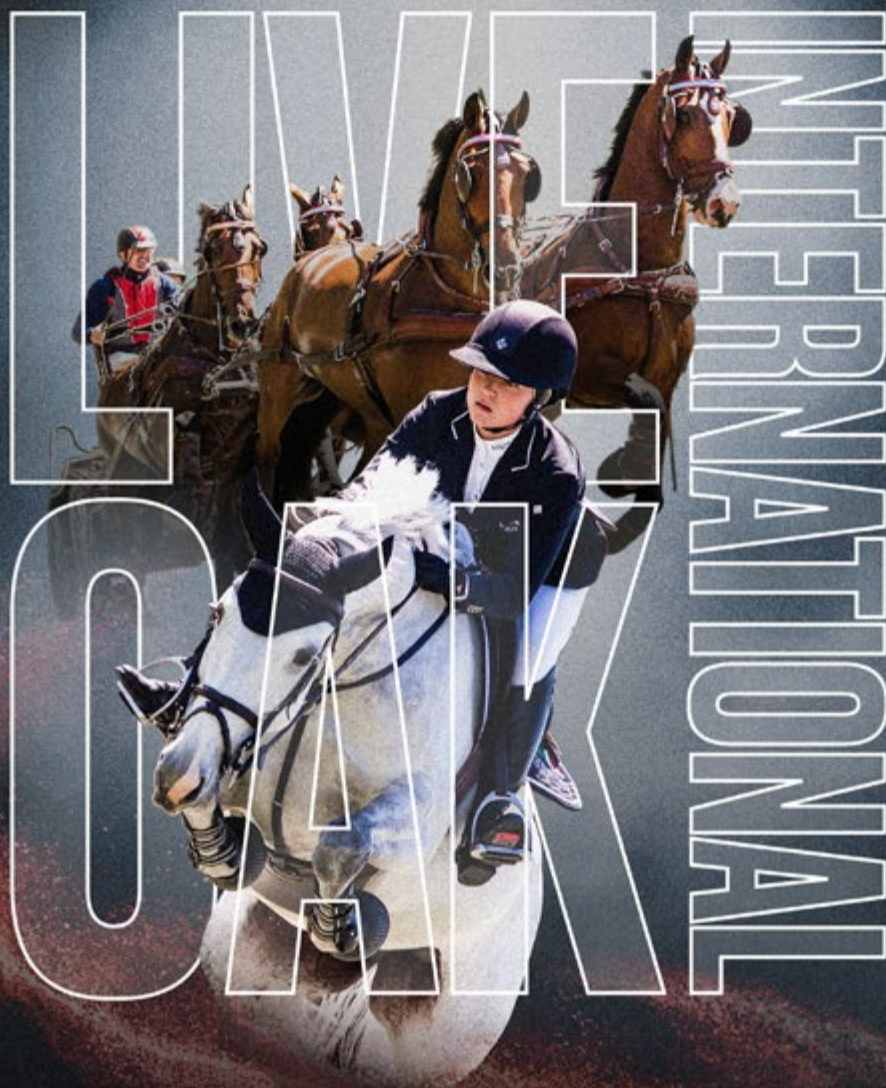



ARRIVALS

Stalls will be available for move-in on Tuesday, March 12, 2024, at 12:00 PM. Move out is required by Monday, March 18, 2024 at 10:00 AM. Horses arriving early will pay \$50 per stall per night. Stalls occupied after 10:00 AM on the 18th will be charged \$50 per stall, per day. Please contact the show office if you would like to arrive early or stay late so arrangements can be made.

Stabling will be assigned at the entry deadline based on your entry form. Please state on your entry form when you will be arriving. IF YOUR ARRIVAL CHANGES, PLEASE CALL OUR OFFICE.

Under no circumstances may a horse be placed in a stall to which it has not been assigned. Violation of this rule will result in a \$250 fine. Competitors must not move from their assigned block of stalls without the permission of the stable manager.

If you are arriving after 5:00 PM, please let the Secretary's Office know - staff are generally not available after hours.

CAMPING

There are camping space available for competitors only. There is a \$100 charge for camping without hookups. Camping with hookups (water and electric) are \$350. Make reservations on entry form. Limited camping spaces available are left to the discretion of the LOI tournament office.

The Live Oak International Tournament will be conducted according to the current rules of the FEI, the USEF and the Organizing Committee of Live Oak International.

In entering tournaments at Live Oak International you and your team (owners, trainers, grooms, family members, agents, etc.) have agreed to honor the General Information as specified in this Prize List, FEI definite schedule, and on the entry form. Your agreement and acceptance of all rules, regulations, and Live Oak International decisions, are indicated by competing at our Tournament.

Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. Headgear

Per USEF Rule GR801.2: It is compulsory for all persons at Federation licensed hunter, jumper, or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. It must be properly fitted with harness secured.

HORSE BRIDLE NUMBERS

1. Horse bridle numbers must be worn by horses at all times (including in the exercise and competition areas as well as bathing) with the exception of the horse's stall - FEI Article 114.2. Use of the wrong bridle number or not having a bridle number may result in disqualification.
2. Bridle numbers are provided by Live Oak International at the time of Check-In. Competitors are welcome to use their own numbers provided they are easily legible (please see the Competitions Manager if you have concerns about your bridle numbers).

LOST & FOUND

The Lost & Found Bin is located in the Secretary's Office. Items not claimed within two weeks of the end of the Tournament will be donated to charity. PLEASE KEEP A CLOSE WATCH ON YOUR BELONGINGS!

ORGANIZING COMMITTEE DECISIONS

1. IT IS IMPORTANT TO UNDERSTAND THAT INTERPRETATIONS OF EXISTING RULES AND REGULATIONS AND THE INVOKING OF ADDITIONAL RULES AND REGULATIONS TO COVER UNFORESEEN CIRCUMSTANCES ARE THE SOLE RESPONSIBILITY AND AUTHORITY OF THE ORGANIZING COMMITTEE. ALL OWNERS, TRAINERS, COMPETITORS AND GROOMS AGREE TO THE ACCEPTANCE OF THESE INTERPRETATIONS AND ADDITIONAL RULINGS BY VIRTUE OF YOUR SIGNED ENTRY.
2. It is the objective of the Organizing Committee to run Live Oak International Tournaments on the highest possible level of sportsmanship. Judges, course designers, and officials have been selected based on their knowledge and experience and their decisions in the competitions are their own responsibility. The Organizing Committee accepts no responsibility for their decisions.

The Organizing Committee is not bound by opinions of its staff, such as Veterinary Doctors, Secretary's Office and Field Staff, in the interpretation of these rules.

PARKING

There will be designated parking areas on the grounds for competitors' vehicles and trailers. Please park in designated areas only - vehicles and trailers will be towed if parked in restricted areas.

PETS

Please keep all pets on a leash and attached to either a fixture or person while at Live Oak. Unleashed pets which become a nuisance (running loose, aggressive to people/horses & a bio security hazard) on the grounds will be taken by our security personnel to a safe area on the grounds. Release may be obtained after payment of a \$100 fine - dogs that are aggressive or vicious will be banned from the grounds.

PROTESTS

Competitors have accepted favorable and unfavorable rulings in the spirit of good sportsmanship. Feel free to bring your unofficial concerns to our Director of Sport for consideration. If you insist on making an official protest, it shall be made in writing and delivered to the Director of Sport accompanied by a deposit as specified per FEI and USEF rules which will be forfeited if the protest is not sustained.

SHARPS DISPOSAL

Receptacles are provided in the stable area, as per USEF GR 1210.4 for the safe disposal of needles and other disposable sharp instruments.

Management will fine individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles and other disposable sharp instruments.

SHOW BILL / CLOSE OUT

ALL PRIZE MONEY WILL BE APPLIED AGAINST THE HORSE ACCOUNT - any credits after the Tournament will be printed on a check. The check will only be issued to the rider/owner as indicated on the entry form and will be paid out within 10 days of the end of the Tournament.

You must pay your tournament bill ("close out") with either cash, a check, debit, or credit card. If you are settling your tournament bill and you are paying with a credit card, you must bring the physical card at the time you close out. All credit cards run manually will be subject to a 3.5% service fee.

SHOW PASS FEE

Effective 12-1-2022 any rider, handler, driver, or owner are limited to one Show Pass purchase annually (December 1-November 30). USEF Show Pass will be available for purchase by exhibitors on-line only. Competitions should not accept payment for show pass fees and therefore this fee should not appear on the entry blank. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for a Show Pass and must obtain a Senior Competing membership to participate in a USEF-licensed competition.

SMOKING

There is a strict NO SMOKING policy in all Live Oak International buildings and stables, as well as within 10 feet of any entrance thereof. Competitors are responsible for the actions of all their staff, owners, trainers, etc. Any person caught smoking in a barn, other building, or outside an entrance will be charged a fine of \$250, which will be applied to the horse's account. Further offenses may result in being asked to leave the Tournament grounds and a forfeiture of Tournament fees paid.

STABLE CREDENTIALS

Credentials for entry to the stable area will be issued as follows: Athlete-1; Partner-1; Trainer-1; Owner up to 2/horse; Groom for jumping-1; Teams-5, Pairs-3, and Singles-1.

Stable Security

1. The Organizer is responsible for the control of all stable areas so that the following minimum security requirements are met:

- a. The welfare of the horse is the first priority.
- b. Stable arrangements and security are at the discretion of the Organizer and shall be approved by of the Technical Delegate. Arrangements must be published with the prize list.
- c. Security fences are not obligatory, but fences and gates may be installed for safety and security reasons at the disc

A wrist band or ticket is required for EVERY person stepping on the tournament grounds. Any member of your team or support staff is required to have a wrist band for entry onto the property. Persons to arrive at the front gate without accreditation will be denied entry. ALL PARTIES HAVE TO BE ON RIDERS LIST FOR ACCREDITATION.

STALLS

Stalls are temporary with canvas on frame doors.

Size of Jumping boxes 3 m x 4 m.

FEI Driving is \$275 per stall. FEI Jumping is \$400 per stall.

Please clearly mark on your entry form with whom you would like to be stabled. Live Oak International makes every effort to assign the requested stabling. However, barn assignment is subject to demand, quarantine requirements, distance traveled, size of barn, and the Organizing Committee. Live Oak International regrets that it may not be possible to make changes after the closing date.

There are a limited number of tack stalls available, please indicate the number of tack/extra stalls you require on your entry forms. Extra stalls or tack stalls cannot be split between multiple horse accounts. Please plan accordingly.

If your horse(s)/tack has arrived before the date stated on your entry form, your account will be adjusted accordingly.

TIME SCHEDULES

THE SCHEDULES IN THIS PRIZE LIST ARE TENTATIVE. Please check with the Secretary's Office or **liveoakinternational.com** for the most up-to-date schedule.

VETERINARY/HEALTH REQUIREMENTS

A negative Coggins test is required for every horse entering the tournament grounds (valid within 1 year of the start of the Tournament). A Health Certificate issued within 30 days, is required for horses entering the State of Florida. FEI entries are required to have the appropriate vaccinations, and passports as per their discipline. Each horse showing and non-showing must have the attached Statement of Health signed by a licensed veterinarian. Daily temperature recordings will be required for all horses. Athletes and grooms are required to follow FEI veterinary regulations and procedures, please download the FEI HorseApp.

WALK TO RING

Distance from Stabling area to Competition area is 0.6 miles / 1 km, approx. 8-10-minute walk.

WASH RACKS

It is prohibited to wash horses in aisles. Wash racks will be available in the stable area.

WITHHOLDING TAX

Foreign competitors must include a US Tax ID Number on their entry form or 30% of their winnings will be withheld as per the Internal Revenue Service policy.

Non-showing horses are not required to jog but must have valid passports and current FEI vaccinations. Scratched horses present on the grounds are considered non-showing.

** Written certificates of disability must be on veterinarian letterhead and signed by the DVM. Doctor's notes must also be on clinic letterhead.

COMPETITORS CANCELING THEIR ENTRIES AFTER THE START OF THE TOURNAMENT,
REGARDLESS OF THE REASON, WILL NOT BE ELIGIBLE FOR A REFUND.

TOURNAMENT AREA CONDUCT

1. No persons other than the officials, stewards, staff on duty, and the judges of the competition may enter the competition arena without the permission of the Director of Sport or the Organizing Committee.
2. Competitors require formal attire as per FEI and USEF rules. Coaches, trainers, and grooms who enter the Competition Ring must be NEAT AND SUITABLY ATTIRED in the opinion of the Hitching Ring officials. Please ask the Director of Sport for dress code advice. This applies to all course inspections.
3. Saluting Protocol: Saluting is very important in giving the sponsors full value. You should stay alert to the In Gate Person's instructions on where to salute once in the ring.
4. The Organizing Committee may determine to preload or not preload at any time during the competition.
5. Competitors are only allowed in the Competitive Ring when competing or when the course is clearly marked "OPEN".

PRESENTATIONS

1. Horses wearing coolers will not be allowed in the Competition Ring.
2. All competitors must be mounted when entering the Competition Ring for presentations.
3. The top eight placings or all in the jump off must be present for the competition awards - competitors who do not comply will forfeit their prize money. Please anticipate in advance the need to ride in for your presentation on a well-mannered horse.
4. Your salute to the sponsor's representatives on the last round of the Victory Gallop is your way of thanking them. Competitors who do not comply will forfeit their prize money.

- Equine Anti-Doping and Controlled Medication Regulations (EADCMR), 3rd Edition, effective 1st January 2021
- FEI Anti-Doping Rules for Human Athletes (ADRHA), based upon the 2021 WADA Code, effective 1st January 2021
- All subsequent published revisions/updates, the provisions of which will take precedence.

EXCUSING OR DISQUALIFYING

1. Any act of discourtesy or disobedience to the Judges, Officials or Staff shall, at the determination of the Organizing Committee, result in disqualification. Such unacceptable behavior will result in forfeiture of Tournament fees paid and prize money, and acceptance in future Tournaments will be determined by the Organizing Committee.
2. The Organizing Committee reserves the right to remove any groom, trainer, rider, driver, parent, manager or owner or all of a related group from the Tournament without being liable for compensation.
3. Inhumane treatment of a horse on the grounds is forbidden and if a violation occurs the Organizing Committee has the right to disqualify the competitor from the Tournament. Such unacceptable treatment will result in forfeiture of Tournament fees paid and prize money, and acceptance in future Tournaments will be determined by the Organizing Committee. Refer to Welfare of the Horse, Code of Conduct, Ethic Committee, FEI Nov. 1990.
4. In jumping competitions, judges have the discretion to eliminate a competitor after a sufficient number of penalties have been incurred which prevent the athlete from qualifying for the final placing.
5. In the case of a disqualification of a horse or horses, the winner of the next succeeding prize shall take the prize that had been awarded to the disqualified horse(s) and the other prizes will be adjusted accordingly.

CODE OF CONDUCT

Live Oak International is committed to the highest of standards of behavior. The sports of driving and show jumping expect these same standards, conduct and behavior from its athletes and their associates.

Disrespect of these standards towards the Live Oak International staff, officials, volunteers, paramedics, or athletes will not be tolerated and may result in the disqualification of horse and rider; all prize money won and monies paid will be forfeited. There will be no appeals on these types of Organizing Committee/Ground Jury decisions.

In the event medical care is required by an individual on Live Oak International property, the medical

services on site have been contracted and authorized by Live Oak International to provide immediate care and have the authority to make decisions in this capacity, including but not limited to: level of care and transportation method to the appropriate treatment facility, should it be deemed necessary.

NOTE CAREFULLY: Extremes of dress and social behavior on the part of athletes, trainers, owners, or associates are not welcome at Live Oak International. At its sole discretion, the Organizing Committee will insist on such individuals leaving the Tournament grounds. Your enthusiasm for high personal standards and adoption of the highest of standards can be your real and meaningful way of supporting and saying thank you to Live Oak International.

Willful damage of property is strictly prohibited and grounds for expulsion from the facility.

All the people of Live Oak International; our professional staff, officials, technicians, our sponsors, the media and our fans are dedicated to you and will make every effort to ensure safe, quality competitions and facilities.

Live Oak International reserves the right to suspend or permanently remove any individual from the grounds for a single egregious act or for escalating behaviors that are contradictory to the Live Oak International Code of Conduct. 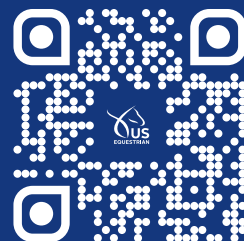

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

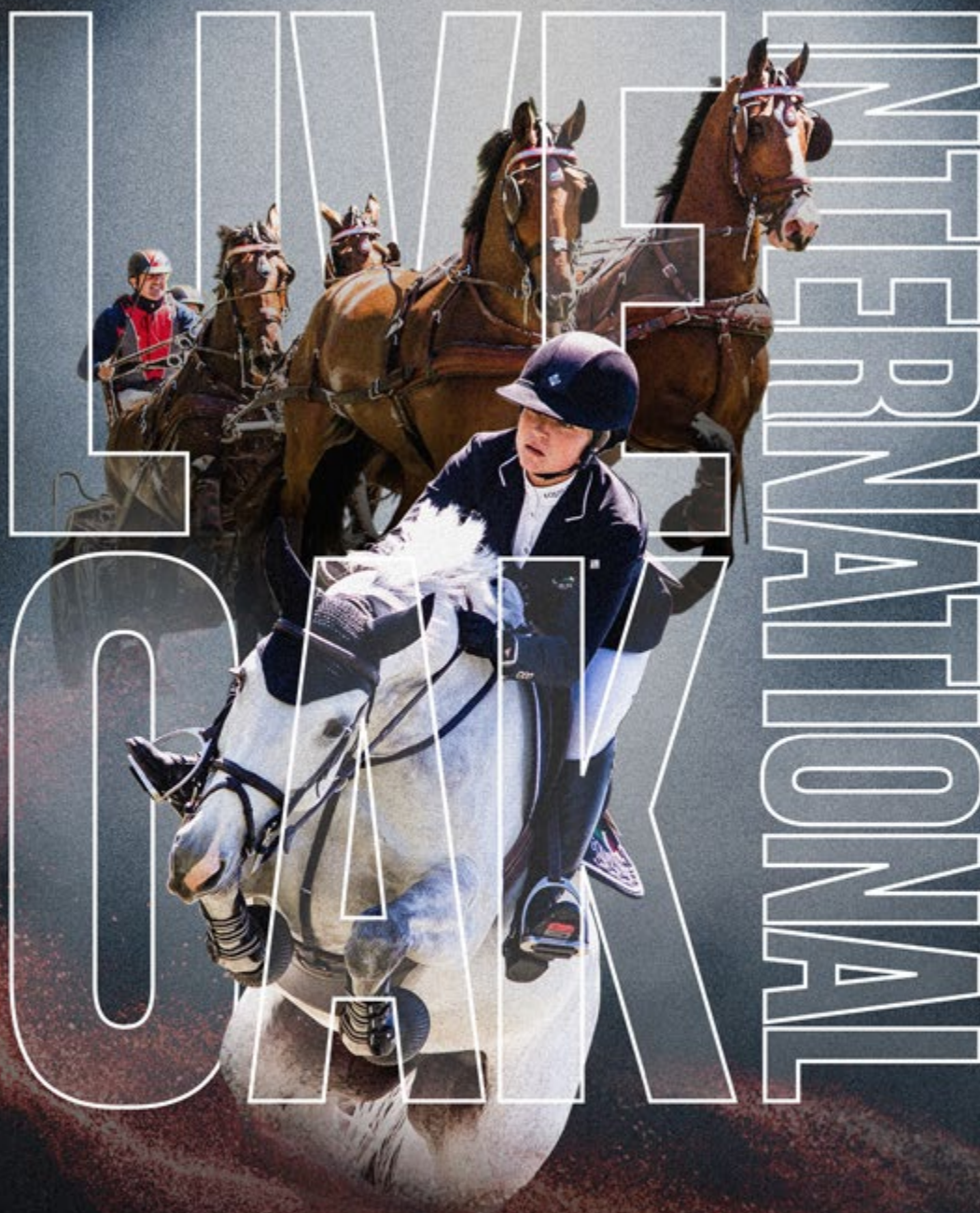
